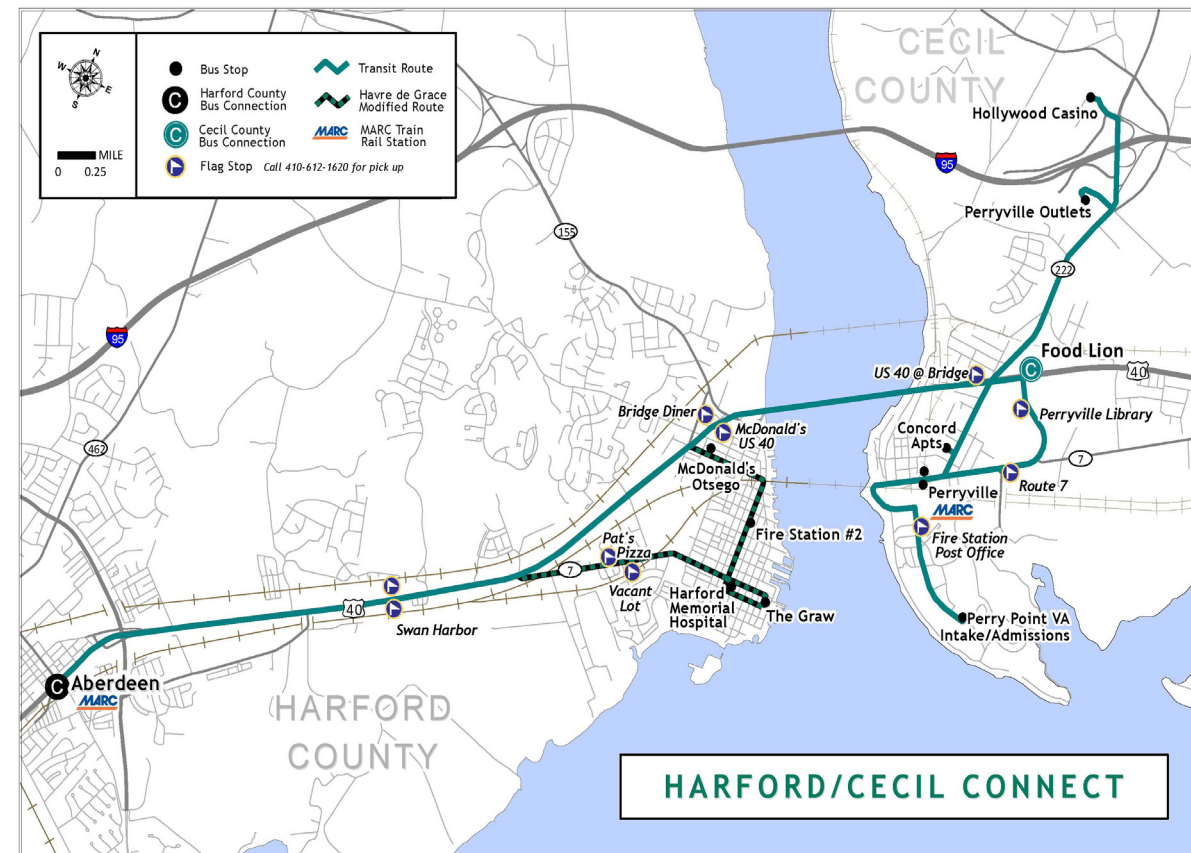
TITLE VI OF THE CIVIL RIGHTS ACT OF 1964

HARFORD TRANSIT LINK AND CECIL TRANSIT

Operating Hours: 5:00 AM-7:00 PM
Monday - Friday (except County holidays)
One Way Trip Time: Approximate 30 minutes or 1 hour for
Havre de Grace Modified Route.

Note: All times are approximate. Arrive at the bus stop at least ten (10) minutes prior to the scheduled time. Stand in clear view and when the bus is arriving to indicate that you wish to board.

Flag Stop at this location: bus will pick up passengers who are visible to the driver; must arrive at Flag Stop ten (10) minutes prior to time listed at previous stop. Call for Flag Stop, 410-612-1620, at least 30 minutes prior to time listed at previous stop.
