AMENDMENT OF FY 2017 BUDGET

FOR the purpose of amending the adopted budget for the Town of Perryville for the fiscal year beginning July 1, 2016, and ending June 30, 2017, to appropriate for certain purposes certain funds and generally related to amendment of the Town's FY 2017 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the "Town of Perryville Budget Fiscal Year 2017 – Final" adopted by Ordinance 2016-09 is amended as follows:

- 1. Decrease the Mayor & Commissioners, Dept. No. 1000, appropriation for "Contingency" from \$119,546 to \$98,852.
- 2. Decrease the Total Mayor & Commissioners, Dept. No. 1000, appropriation from \$166,296 to \$145,702.
- 3. Increase the Administrative, Dept. No. 1100, appropriation for "Salaries, Emp. Taxes, Benefits" from \$290,563 to \$294,574.
- 4. Increase the Total Administrative, Dept. No. 1100, appropriation from \$307,913 to \$311,924.
- 5. Increase the Finance, Dept. No. 1200, appropriation for "Salaries, Emp. Taxes, Benefits" from \$148,283 to \$149,605.
- 6. Increase the Total Finance, Dept. No. 1200, appropriation from \$158,933 to \$160,255.

- 7. Increase the Planning & Zoning, Dept. No. 1300, appropriation for "Salaries, Emp. Taxes, Benefits" from \$207,275 to \$208,644.
- 8. Increase the Total Planning & Zoning, Dept. No. 1300, appropriation from \$377,940 to \$379,309.
- 9. Increase the Engineer, Dept. No. 1450, appropriation for "Salaries, Emp. Taxes, Benefits" from \$32,152 to \$32,360.
- 10. Increase the Total Engineer, Dept. No. 1450, appropriation from \$35,102 to \$35,310.
- 11. Increase the Police / Public Safety, Dept. No. 1500, appropriation for "Salaries, Emp. Taxes, Benefits" from \$1,082,888 to \$1,091,971.
- 12. Increase the Total Police / Public Safety, Dept. No. 1500, appropriation from \$5,930,674 to \$5,939,757.
- 13. Increase the Outreach, Dept. No. 1550, appropriation for "Salaries, Emp. Taxes, Benefits" from \$147,054 to \$148,081.
- 14. Increase the Total Outreach, Dept. No. 1550, appropriation from \$179,779 to \$180,806.
- 15. Increase the Public Works, Dept. No. 1600, appropriation for "Salaries, Emp. Taxes, Benefits" from \$322,673to \$326,247.
- 16. Increase the Total Public Works, Dept. No. 1600, appropriation from \$942,246 to \$945,820.
- 17. Increase Total General Fund appropriation from \$10,750,578 to \$10,750,578. No Change
- 18. Increase the Water, Dept. No. 2000, appropriation for "Salaries, Emp. Taxes, Benefits" from \$476,295 to \$482,699.
- 19. Increase the Water Distribution, Dept. No. 2100, appropriation for "Salaries, Emp. Taxes, Benefits" from \$42,078 to \$42,595.
- 20. Decrease the Water, Dept. No. 2000, appropriation for "Contingency" from \$20,092 to \$13,171.
- 21. Increase the Total Water, Dept. No. 2000/2100, appropriation from \$1,524,271 to \$1,524,271. **No Change**
- 22. Increase the Sewer, Dept. No. 3000, appropriation for "Salaries, Emp. Taxes, Benefits" from \$503,078 to \$510,081.
- 23. Increase the Sewer Collection, Dept. No. 3100, appropriation for "Salaries, Emp. Taxes, Benefits" from \$58,230 to \$59,645.
- 24. Decrease the Sewer, Dept. No. 3000, appropriation for "Contingency" from \$35,176 to \$26,758.
- 25. Increase the Total Water, Dept. No. 2000/2100, appropriation from \$2,089,232 to \$2,089,232. **No Change**

SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the sums and amounts reflected in Section 1 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2016, and ending June 30, 2017.

SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the sums and amounts reflected

in Section 1 of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2016, and ending June 30, 2017.

SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become effective on the day following its approval by the Commissioners.
