AN ORDINANCE concerning

TOWN PARKS AND FACILITIES PERMITS

FOR the purpose of altering the process and requirements for rental of certain Town parks and facilities; authorizing the establishment of certain fees by Resolution; altering certain insurance requirements; and generally relating to rental of Town parks and facilities.

BY repealing and reenacting, with amendments

Chapter 61 Parks and Playgrounds

Section 61-1.B.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that Section 61-1.B. of the Code of the Town of Perryville, Chapter 61, Parks and Playgrounds, is repealed and reenacted, with amendments, to read as follows:

Chapter 61 -PARKS AND PLAYGROUNDS

§ 61-1. Permits.

B. Application for a permit to reserve a pavilion or other facilities within Town park property shall be made in writing to the Town Administrator or his OR HER designee. At the time said application is made, a permit fee as established by Resolution of the Mayor and Commissioners shall be paid to the Town. UNLESS EXEMPTED BY RESOLUTION OF THE MAYOR AND COMMISSIONERS, ((Applications)) APPLICATIONS for a permit submitted by a sponsored group shall be required to provide a certificate of liability insurance to the Town of Perryville at the time of the application in an amount equal to at least ((five hundred thousand)) ONE MILLION dollars (((\$500,000)) \$1,000,000.) liability coverage PER CLAIM EACH for personal AND BODILY injury and property damage. The Town retains the right to deny any application based upon past adverse experiences by the Town with the applicant or the group the applicant represents, or past park use violations by the applicant or the group the applicant represents. Permit fees generated shall be used for cleanup and maintenance of the park and shall be deposited in a separate park maintenance fund. ((Permit fee and cleanup deposit to be paid to the Town for reservation of a pavilion at the Town Park located on the Town Park property south of the Perry Point Veterans Administration Medical Center shall be as follows:

Deposits and)) Permit Fees will be refunded upon receiving the cancellation request in writing within two weeks prior to the event. ((If cancellation is not within the two week time frame, only the deposit will be refunded. Deposit refunds for any reservation will be completed within five (5) business days.)) The Park and Pavilions will be inspected after use and the APPLICANT ((Deposit)) shall be LIABLE FOR ANY ((refunded if the Park and Pavilions are left in a neat and orderly fashion and if no)) damage has been found to have been done to the Park and Pavilions.

SECTION 2. AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become effective at the expiration of twenty (20) days following approval by the Mayor and Commissioners.
