## AN ORDINANCE concerning

## AMENDMENT OF FY 2018 BUDGET

FOR the purpose of amending the adopted budget for the Town of Perryville for the fiscal year beginning July 1, 2017, and ending June 30, 2018, to appropriate for certain purposes certain funds and generally related to amendment of the Town's FY 2018 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the "Town of Perryville Budget Fiscal Year 2018 - Final" adopted by Ordinance 2017-08 is amended as follows:

- 1. Increase General Services, Dept No. 1400, appropriation for "Capital Expenditures" from \$0 to \$669,075.
- 2. Increase the Total General Services, Dept No. 1400, appropriation from \$455,471 to \$1,124,546.
- 3. Increase "Decreased Reserved (LIF) Fund Balance", Revenue No, R1604, from \$1,403,073 to \$2,072,148.
- 4. Increase the Total General Fund Appropriation from \$6,110,797 to \$6,779,872.
- 5. Increase Parks and Recreation, Dept No 1700, appropriation for "Capital Expenditures" from \$46,342 to \$226,605.
- 6. Increase Total Parks and Recreation Dept No. 1700, total appropriation from \$285,354 to \$465,617.
- 7. Increase "Decreased Reserved (LIF) Fund Balance", Revenue No. R1604 from \$2,072,148 to \$2,252,411.
- 8. Increase the Total General Fund Appropriation from \$6,779,872 to \$6,960,135.

SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the sums and amounts reflected in Section I of this Ordinance are hereby appropriated for the fiscal year beginning July I, 2017, and ending June 30, 2018.

SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become effective on the day following its approval by the Commissioners.
