**AN ORDINANCE concerning**

**ALCOHOLIC BEVERAGES ON TOWN PROPERTY**

**FOR** the purpose of creating an exception to certain prohibitions against possession of certain containers of alcoholic or intoxicating beverages on certain publicly owned property in the Town; eliminating an existing exception to such prohibition; and generally relating to possession of containers and consumption of alcoholic beverages in the Town of Perryville.

**BY** repealing and reenacting, with amendments  
Chapter 61 Parks and Playgrounds  
Section 61-17  
Code of the Town of Perryville

**SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE** that Section 61-17 of the Code of the Town of Perryville, Chapter 61, Parks and Playgrounds, is repealed and reenacted, with amendments, to read as follows:

**Chapter 61 – Parks and Playgrounds**

**§ 61-17. Alcoholic Beverages.**

The possession or consumption of alcoholic beverages, including but not limited to beer, wine and all forms of liquor, shall be prohibited within the confines or boundary of any public park or playground owned by or within the corporate limits of the Town of Perryville, EXCEPT AS MAY BE AUTHORIZED BY THE MAYOR AND COMMISSIONERS IN ACCORDANCE WITH SECTION 26-2.A.1. OF THIS CODE. ((Notwithstanding the previous sentence, a person sponsoring or participating in a licensed wine tasting event at a farmer's market operated by the town may possess an open container of, and consume, wine used or distributed as part of the wine tasting event.))


**SECTION 2. AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE** that this Ordinance shall become effective twenty (20) days following its approval by the Mayor and Commissioners.


