AN ORDINANCE concerning

Alcoholic Beverages on Town Property

FOR the purpose of eliminating an exception to certain prohibitions against possession of certain containers of alcoholic or intoxicating beverages on certain publicly owned property in the Town; and generally relating to possession of containers and consumption of alcoholic beverages in the Town of Perryville.

BY repealing and reenacting, with amendments

SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that Section 26-2.A. of the Code of the Town of Perryville, Chapter 26, Alcoholic and Intoxicating Beverages, is repealed and reenacted, with amendments, to read as follow:

CHAPTER 26 – Alcoholic and Intoxicating Beverages

§ 26-2. Possession of Beverages or Containers; applicability.

A. A person shall not possess in an opened container an alcoholic or intoxicating beverage or a container that had contained alcoholic or intoxicating beverages on any of the streets, alleys, sidewalks, parks or ways of the Town of Perryville or on the parking lots of private property that is used by the public unless authorized by the owner of the said property. ((Notwithstanding the previous sentence, a person sponsoring or participating in a licensed wine tasting event at a farmer's market operated by the town may possess an open container of wine used or distributed as part of the wine tasting event.))

SECTION 2. AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become effective twenty (20) days following its approval by the Mayor and Commissioners.
