## **RESOLUTION NO. 2016-15**

A RESOLUTION OF THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE, MARYLAND to establish procedures for the issuance of resident and non-resident boat ramp permits.

**WHEREAS**, Section 61-22.C. of the Perryville Town Code requires the Mayor and Commissioners to establish by Resolution the procedure for issuance of seasonal and daily boat ramp permits.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that, the following procedures shall be utilized for the issuance of seasonal and daily boat ramp permits:

## **Seasonal Permits:**

- 1. Application for issuance of a seasonal boat ramp permit shall be made at Town Hall during normal Town business hours.
- 2. Applications shall be made on forms prescribed by the Town Administrator.
- 3. Applications shall be accompanied by proof of boat registration in Maryland and/or an authorized rental contract for a boat registered in Maryland.
- 4. For persons not residing in MARYLAND, applications for seasonal permits shall be accompanied by proof of boat registration and/or an authorized rental contract for a boat. Non-resident seasonal permits will be issued to non-residents subject to availability within the limit of non-resident seasonal permits authorized by the Mayor and Commissioners.
- 5. Applications for seasonal permits shall be accompanied by payment for a permit in the amount established by the Mayor and Commissioners.
- 6. Seasonal permits will be issued by Town staff upon verification of applicant eligibility and payment of the permit fee. The applicant shall prominently display the permit on the driver's side of the tongue of the trailer one foot from the vehicle hitch device.

## **Daily Permits**

- 1. Application for issuance of a daily boat ramp permit shall be made at the boat ramp location prior to use of the boat ramp.
- 2. Applications shall be made on forms prescribed by the Town Administrator and available at the boat ramp. Applications shall contain a detachable permit to be retained by the applicant upon completion of the application form.
- 3. An application for a daily permit and the applicable permit fee as established by the Mayor and Commissioners shall be deposited in a sealed envelope into a locked container provided for that purpose at the boat ramp.
- 4. Prior to depositing the completed application and permit fee the applicant shall detach and retain the permit included with the application. The applicant shall prominently display the permit on the applicant's vehicle's dashboard.

AND BE IT FURTHER RESOLVED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Resolution shall become effective on the date that Ordinance 2016-22 becomes effective, and if Ordinance 2016-22 does not become effective this Resolution shall stand rescinded without further action of the Mayor and Commissioners.
