1. Budget Amendment – Introduction - Bringing over funds from 2017 budget for Town Hall Complex

Commissioner Linkey introduced the budget amendment. She stated the purpose is to amend the adopted budget for the Town of Perryville for the fiscal year beginning July 1, 2017, and ending June 30, 2018, to appropriate for certain purposes certain funds and generally related to amendment of the Town's FY 2018 budget.

Ordinance 2017-13 - Budget Amendment Ordinance for funds previously budgeted for grants whose grantees' were given extensions until FY18 to do their work, funds previously budgeted to do final asphalt, as-builts & misc. for Lower Ferry Park, funds previously budgeted for Rodgers Tavern misc. restoration, for 2 bus shelter installations, for Town street lighting, for Police Dept. furniture, and new server for new Police Station.
