### AN EMERGENCY ORDINANCE concerning

#### AMENDMENT OF FY 2023 BUDGET

FOR the purpose of amending the adopted budget for the Town of Perryville for the fiscal year beginning July 1, 2022, and ending June 30, 2023, to appropriate for certain purposes certain funds for the replacement of the Waste Pump Station Muffin Monster and appropriating funds for the cut to Mill Creek and generally related to amendment of the Town's FY 2023 budget.

SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the "Town of Perryville Budget Fiscal Year 2023 - Final" adopted by Ordinance 2022-05 is amended as follows:

- 1. Increase by \$215,000, Waste Pump Stations, Dept 3100, appropriation for "Capital Outlay".
- 2. Increase by \$215,000, Waste Pump Stations, Dept 3100, appropriation for "Total Expenditures".
- 3. Increase by \$215,000, appropriation for "Total Sewer Fund Expenditures".
- 4. Increase by \$215,000, "Total Appropriations".

- 5. Increase by \$215,000, Sewer Fund, "Decrease to Retained Earnings", Revenue No. R 3601.
- 6. Increase by \$215,000, "Total Sewer Fund Revenue".
- 7. Increase by \$215,000, "Total Revenue".

#### Amendment B

- 8. Increase by \$40,000, Waste Pump Stations, Dept 3100, appropriation for "Capital Outlay."
- 9. Increase by \$40,000, Waste Pump Stations, Dept 3100, appropriation for "Total Expenditures".
- 10. Increase by \$40,000, appropriation for "Total Sewer Fund Expenditures".
- 11. Increase by \$40,000, "Total Appropriations".
- 12. Increase by \$40,000, Sewer Fund, "Decrease to Retained Earnings", Revenue No. R3601.
- 13. Increase by \$40,000, "Total Sewer Fund Revenue"
- 14. Increase by \$40,000, "Total Revenue".

SECTION 2: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that the sums and amounts reflected in Section I of this Ordinance are hereby appropriated for the fiscal year beginning July 1, 2022, and ending June 30, 2023.

SECTION 3: AND BE IT FURTHER ENACTED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become effective on the day following its approval by the Commissioners.
