32 **SECTION 1. BE IT ENACTED BY THE MAYOR AND COMMISSIONERS OF**
33 **THE TOWN OF PERRYVILLE** that Section 82-2.J.(3) of the Code of the Town of Perryville,
34 Chapter 82, Water and Sewers, Article I Transitional Provisions; Charges; Disposition of
35 Revenue, is repealed and reenacted, with amendments, and to read as follows:

48 (3) In addition to the criteria for an adjustment set forth in paragraphs 1 and 2 of this
49 subsection, a person may not receive an adjustment of the water or sewer
50 amounts of the bill (I) if that person or property has received an adjustment
51 within the past 36 months ((, or)) (II) if all or a portion of the charge for excess
52 water usage has been reimbursed under a policy of insurance; OR (III) IF A
53 PROPERTY OWNER HAS NOT RECTIFIED, WITHIN 30 DAYS FROM
54 THE DATE THAT THE TOWN MAILS WRITTEN NOTICE OF THE LEAK
55 TO THE PROPERTY OWNER, THE LEAK GIVING RISE TO THE
56 EXCESSIVE WATER USAGE.

60 SECTION 2. AND BE IT FURTHER ENACTED BY THE MAYOR AND
61 COMMISSIONERS OF THE TOWN OF PERRYVILLE that this Ordinance shall become
62 effective at the expiration of twenty (20) days following approval by the Mayor and
