**AN ORDINANCE** concerning.

**TRASH COLLECTION COST**

**FOR** the purpose of establishing a fee for the Town’s collection of household garbage, rubbish, trash and recyclables from certain residential units; and generally relating to fees for collection of certain garbage, rubbish, trash and recyclables in the Town of Perryville.

**BY** adding  
Chapter 50, GARBAGE, RUBBISH AND REFUSE  
Sections 50-2. C.  
Code of the Town of Perryville

**EXPLANATION:**

31           **SECTION 1. BE IT ENACTED, BY THE MAYOR AND COMMISSIONERS**  
32 **OF THE TOWN OF PERRYVILLE** that new Section 50-2.C, is hereby added to the Code  
33 of the Town of Perryville, Chapter 50, GARBAGE, RUBBISH AND REFUSE, to follow  
34 immediately after Section 50-2. B. and to read as follows:

36                           **Chapter 50, GARBAGE, RUBBISH AND REFUSE**

38 **§ 50-2. Normal household garbage; regulations.**


40           C. EACH RESIDENTIAL UNIT IN THE TOWN SHALL BE CHARGED A FEE  
41 ANNUALLY FOR THE TOWN'S COLLECTION OF HOUSEHOLD  
42 GARBAGE, RUBBISH, TRASH AND RECYCLABLES. THE AMOUNT OF  
43 THE FEE SHALL BE 10% OF THE TOWN'S COST PER RESIDENTIAL  
44 UNIT FOR THE COLLECTION OF HOUSEHOLD GARBAGE, RUBBISH,  
45 TRASH AND RECYCLABLES. THE FEE SHALL BE BILLED  
46 QUARTERLY AS A LINE ITEM ON THE RESIDENTIAL UNIT'S WATER  
47 AND SEWER BILLING. UNTIL PAID IN FULL, UNPAID FEES AND  
48 INTEREST THEREON SHALL BE A LIEN UPON THE RESIDENTIAL UNIT  
49 SERVED, AND SHALL BEAR THE SAME INTEREST AND PENALTIES,  
50 AND BE COLLECTIBLE IN THE SAME MANNER, AS TOWN REAL  
51 PROPERTY TAXES.  
52

53           **SECTION 2. AND BE IT FURTHER ENACTED** that this Ordinance shall  
54 take effect twenty (20) days following approval by the Mayor and Commissioners.


