
Ordinance 2020-10 Water and Sewer Connection Fees

Ms. Breder stated that this is the ordinance that changes how the connection fees are used. It now would require the developer or property owner to make the physical connections to the water and sewer main at their cost and expense and changes the ability for the Town to use those connection fees for other purposes such as capital projects or debt service. It also allows for changes in the duties of different staff members as far as water and sewer goes and how we collect the collection fees. The connection fees used to be by meter size and now it is by equivalent dwelling units, which is a more simplified method with the same results. This was introduced at the September Town Meeting, so she is asking for a vote on this ordinance tonight.

Mayor Ashby asked if the board members had any questions, which there were none, so he asked for a motion.
