Ms. Laubach was requesting a motion for an extension of the contract with our current auditors and is recommending an extension of 4 years, which would be two 2-year extensions. A contract will be formalized once approved.

Chesapeake Overlook Parkway Road Dedication - Dianna

Ms. Battaglia had stated in the Work Session that we have the Deed of Dedication with the metes and bounds description and the plat that shows that section of road designated to the Town of Perryville as a Town road.

Motion was made by Commissioner Snelling and seconded by Commissioner Aldridge to approve the Chesapeake Overlook Parkway Road dedication.

Commissioner Linkey inquired if we need to add something to this motion, wasn't something mentioned that may or may not have been done to the road.

Mayor Ashby responded that it was the asphalt topper, and he asked Ms. Breder if she recalls if that is how that went, if they were not going to put the top coat on until all of the construction was done.

Ms. Breder was not sure, but believes there is a bond posted by Stewart for finishing the roadway, but her biggest concern right now is that we still have not received the Title report that Mr. Sussman has to review.

Mayor Ashby responded that he will not sign it until we get that.

Commissioner Linkey inquired if we can table this until all of the information is received.

Mayor Ashby responded that we cannot, he will not sign it until we get the Title dedication.

Ms. Breder stated that we can amend the motion to say upon receipt of the title, that it can be approved.

Mayor Ashby responded that we do not have to do that he does not have to sign it until we get the title.

Commissioner Linkey asked what about the asphalt.

Ms. Breder responded that there is a bond posted for completion of the road.

Commissioner Taylor inquired if the bond was filed with the Town of Perryville, or with the County.

Ms. Breder responded that it is with the Town of Perryville.

Mayor Ashby stated that he will not sign the dedication until the Title search is received, which was supposed to be today.

The original motion was brought forward for a vote.
