Mayor Ashby read the introductory paragraph of the Small Cell Ordinance 2020-04, for the purpose of providing certain standards and regulations relating to the location of small wireless telecommunications towers, antennas, and other structures within the Town's public rights-of-way, consistent with federal and state law; providing for fees and annual charges; establishing design guidelines for small wireless telecommunications towers, antennas, and other structures; and generally related to the wireless telecommunication facilities and wireless infrastructure providers in the Town of Perryville.
